 Helmet rental available @ \$25 per week.

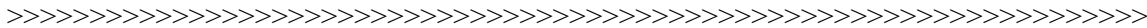
Fees: Early bird rate (paid before June 1, 2010): \$350 per week + HST

HST Clarification

We have been learning as we go with the pending HST.

We have confirmed with our accountant that HST must be collected on services that are used or delivered after July 1, 2010. This includes camp.

Accordingly, HST must be added to camp fees, even if paid before July 1.

We continue to offer the early-bird camp rate (payment before June 1), to help ease the burden.

Lessons and board will remain unchanged for May and June. However, fees for lessons and board for July 1 onward will reflect the new HST.

We apologize for any confusion about camp rates during this transition.

Camp Fees

Early bird rate \$350 per week + HST (13%) = \$ 395.50
(paid before June 1, 2010)

Regular rate \$400 per week + HST (13%) = \$ 452.00
(paid after June 1)

Volume discount (for each extra week or immediate family member): \$10 off
